



Dr Michaela Benson is a Reader in Sociology at Goldsmiths, University of London. Her current research, *Britain and its overseas citizens: from decolonisation to Brexit* is funded by the British Academy's Mid-Career Fellowship. She is also Co-I for a new ESRC-funded project *Rebordering Britain and Britons after Brexit* (MIGZEN) (2021-23), a collaboration with Professor Nando Sigona (University of Birmingham) that explores how Britain's shifting position in the world in consequence of Brexit impacts on migration and mobility to and from the UK. These projects build on her career-long interest in British citizens living overseas, notably through her leadership of the UK in a Changing Europe funded research project (2017-19), *BrExpats: Freedom of Movement, Citizenship and Brexit in the lives of Britons living in the EU-27* and her book *The British in Rural France* (Manchester University Press, 2011).



Barbara Drozdowicz is the CEO of East European Resource Centre. In London since 2008, she joined the EERC in 2012, having earlier been involved in the charities support sector as a governance and funding adviser. Barbara worked in Poland in a number of European social inclusion projects targeting homeless and other persistently socially excluded groups, including the first reconnection project for the Polish homeless in London.



Caitlin Boswell is the Project Officer for EU citizens at JCWI. Caitlin joined JCWI in July 2019 to lead on the EU citizens project, campaigning for EU citizens' rights through reform of the EU Settlement Scheme and monitoring its impact particularly for marginalised groups most at risk of slipping through the cracks in the scheme. Prior to this she worked as an Advocate & Outreach Worker, providing one-to-one support for migrant women affected by the criminal justice system and/or immigration restrictions. Before working in the migration sector, Caitlin studied for a Masters in Gender & Law at SOAS, writing her thesis on the UK asylum system's treatment of LGBTQ asylum seekers.



Nicolas Hatton is the CEO of the3million, the largest organisation campaigning on EU citizens' rights in the UK. the3million started in 2016 as a grassroots organisation by EU citizens, for EU citizens in the UK. the3million advocates for the interests of EU citizens' in the UK and currently monitors the implementation of the Withdrawal Agreement and runs campaigns on access to citizenship and democratic rights.



Mihai Calin Bica works for the Roma Support Group since 2016, coordinating the Roma Brexit Campaigning and Policy Project. Mihai is a Romanian born, Roma ethnic with over 10 years of experience working with Roma ethnics in different areas such as human rights, housing, employment education and immigration. Roma Support Group was set up in 1998 and is the first and the biggest Roma charity in the UK, supporting, mainly East European Roma, successfully settle in the UK.



**Catherine Sarah Barnard**, FBA is a British legal scholar, who specialises in European Union, employment, and competition law. She has been Professor of European Union and Employment Law at the University of Cambridge since 2008.



Laura Morosanu is Senior Lecturer in Sociology at the University of Sussex and Associate Editor of the Journal of Ethnic and Migration Studies. She is interested in migrants' social lives, work trajectories, and identities, and has explored these in the context of intra-European youth mobility. She co-convenes the Ethnicity, Race and Diverse Societies at Sussex, and the Standing Committee on Gender and Sexuality in Migration Research within IMISCOE.



Sunder Katwala is the director of British Future, an independent and non-partisan think-tank that works on identity and immigration, integration and opportunity. Sunder was previously General Secretary of the Fabian Society and a journalist with the Observer. He regularly contributes to national media debates on identity and immigration in Britain today.
